The Golden Visa is the best answer

With more than a decade of existence, the Golden Visa in Portugal has contributed more than 7 billion euros to the Portuguese economy.

In case you are not familiar with the term, the Golden Visa is an economic strategy aimed at attracting foreign investments, particularly in countries struggling with economic challenges.

Originally proposed by the International Monetary Fund (IMF) in 2008, the programme serves as a tool to fortify and rejuvenate economies. Its impact on the real estate market in Portugal has been notable and largely positive across the country's diverse real estate market offerings.

Introduced in 2012, the Portugal **Golden Visa Programme allows** American citizens to obtain a **Residency Permit and be eligible** for Portuguese Citizenship in exchange for a 6-year investment commitment.

The Portugal Golden Visa has gained immense popularity globally due to several factors, including property prices' affordability, which are among the lowest in all EU capitals.

Additionally, Portugal's attractive living conditions, renowned safety, high quality of life, and robust public healthcare system contribute to its allure.

The programme offers advantages such as visa-free travel within the Schengen Zone and the option to live, work, and study in Portugal, and many more, making it an appealing choice for investors.

Portugal Golden Visa holders are also required to only spend a minimum of 14 days in the country, either consecutively or intermittently, within each 2-year visa period.



Portugal: a New Favourite Destination for Americans

Americans are choosing Portugal as a new place to set Residency. But not only – tourism from the U.S. to Portugal also increased dramatically in the last decade making this the best period for the Portuguese tourism industry, making the country a top destination for travellers from the United States.

One good reason for that is the convenience offered by the Portuguese national airline, TAP, with its famous stopover deal—where a traveller can choose to stop in Portugal for up to 10 days before reaching their final destination—which has made Portugal an accessible and attractive destination. Incredible, right? Keep reading this guide to find out more about this great feature.

This trend of Americans visiting Portugal was particularly evident in May 2024, when the tourism accommodation sector recorded 3.1 million guests and 7.7 million overnight stays, reflecting increases of 9.4% and 7.5%, respectively, compared to the previous month.

Data released by Statistics Portugal (Instituto Nacional de Estatística, INE) shows that





Chart 1 – Distribution of overnight stays by non-residents.





overnight stays by non-residents surged by 7.5%, totalling 5.8 million in 2023. Among international markets, the U.S. stood out by securing the third position, accounting for 10.1% of total overnight stays and experiencing a remarkable 17.3% growth.

This growth allowed the U.S. market to surpass traditional visitors like citizens from France, which saw a slight decline.





Chart 3 – Distribution of American residents in Portugal (September 2023).



American tourists are increasingly attracted to Portugal's diverse regions, with significant growth in areas like the Alentejo (+18.0%) and the Azores archipelago (+17.6%). This rising interest from the US has contributed to higher occupancy rates, with May 2024 seeing an increase to 52.4% for bed occupancy and 63.7% for room occupancy, further solidifying Portugal's appeal as a top destination for American travellers.

Fun fact: Portugal was one of the first countries to recognise the American independence, on February 15, 1783, before the final Treaty of Paris was signed.

It is true that Portugal was overlooked for several decades by American tourists, who preferred destinations such as France, Italy, and Spain.

However, it is incorrect to think that the relations between the two countries have been weak in any way. In fact, Portugal and the United States have a longstanding relationship.

In 1791, Queen Maria I of Portugal officially acknowledged the U.S. as an independent country, making Portugal the third country to do so, following France and the Netherlands. Cool, right?

The United States is one of Portugal's primary trading partners and often ranks as Portugal's largest non-EU trading partner. Additionally, the US is a significant source of investment in Portugal. The deep-rooted connections between the two nations are further illustrated by the Portuguese communities in the US, which have thrived for over a century. In 2024, there are more than 200,000 Portuguese nationals and over 1.4 million Portuguese descendants living legally in the United States, actively contributing across various sectors and holding significant political representation. The official number of Americans with temporary or permanent residency in Portugal has also been increasing over the years.

According to Statistics Portugal, there were 9,772 American residents officially living in Portugal as of September 2023. Of these, 9,034 were in mainland Portugal, 450 in the Madeira Islands, and 288 in the Azores archipelago.



Increasing Convenience and Affordability:

More Flights from the U.S. to Portugal

Portugal's geographical location on the western edge of Europe makes it one of the closest European destinations to the U.S. For instance, flights from New York to Lisbon are some of the shortest transatlantic flights available, typically taking around 7 hours. This proximity is a significant advantage for those looking to maximise their time exploring rather than travelling. If you think 7 hours is too much, how about flying to a whole new continent taking only 5 hours?

Yes, there is one non-stop flight connection between Boston airport (BOS) and Ponta Delgada airport (PDL) in the Azores that takes only 5 hours, which is operated by Portuguese Azores Airlines - SATA. Portugal is well-connected to various major US cities. Here is a detailed list of direct flight connections, including approximate flight length.





Family Reunification

The process is easy, but it does involve gathering some documentation, both in Portugal and in the United States.


1-18 Months


Year 1 & 2

Year 3 & 4

At this point, you will have to renew your Portugal Golden Visa for another 2 years. You will retain all your Residency benefits during this time.



Year 5 & 6

Even though your Golden Visa is valid for another 2 years, by the 5th year mark, you are now eligible to apply for either Permanent Residency or Citizenship. Unlock all the benefits of an EU Passport with the Portugal Golden Visa.




